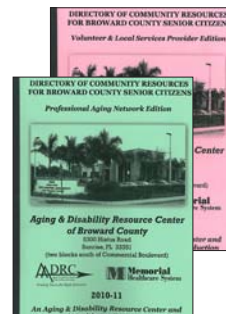
Board Will Gather Second Thursday in June
